**AMENDMENT TO THE CONSTITUTION of Goans Hockey at the Extra Ordinary General Body Meeting held on 8th September 2022 at the Manohar Parrikar Indoor Stadium, Navelim.**

Clubs who are seeking affiliation to Goans Hockey will be admitted as Associate Members . To be granted Permanent Membership the Club will have to conduct Hockey Tournaments or participate in the State Championships. And the existing clubs who have not participated in the state championships or who have not held their elections will be downgraded to Associate Member.
